On Monday, March 26th, if there are any remaining tickets, sales will be opened to non-residents. **Payment for all tickets must be made in full at the time of purchase**. Each household will be limited to purchasing a maximum of 4 tickets for 2 games. Tickets will be distributed on the bus. No refunds will be issued. We will do our best to accommodate all ticket requests, however, there is no guarantee that seats will be together due to ticket allocation. We will honor your requests whenever possible and apologize for any inconvenience this may cause. ***All game times are subject to change at the discretion of the Boston Red Sox.**
